HCID#2 shall pay all attorney and water right transfer fees.

Director Slovak made a motion that was seconded by Director Ybarra and passed by unanimous vote for the board president to sign the Certified Resolution to Exclude all subdivisions that have less than one acre and are not taxed.

Director Reyes made a motion that was seconded by Director Ybarra and passed by unanimous vote for the president to sign the Partial Release of Easement to Cameron County. Being: 1,121 SQ. Ft. Partial Release of Easement of Brownsville Irrigation District's 30 ft. wide R.O.W. and Easement within Lot 10, Block 110, El Jardin Re-Subdivision, Espiritu Santo Grant, Cameron County, Texas, Recorded in Volume 930, Page 202, deed records of Cameron County, Texas.
